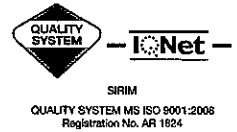

FOREIGN WORKERS LEVY INCREASE EFFECTIVE FROM 1ST SEPTEMBER 2011

Please be informed that MBAM has received a notification from the Ministry of Home Affairs, Malaysia (KDN) stating that the levy for foreign construction worker will be increased from the current RM1,200.00/year to RM1,250/year with effect from 1st September 2011.
